1 Overview

Billing Modes

Message & SMS provides two billing modes to meet different requirements.

- Pay-per-use: postpaid mode in which you pay as you go and just pay for what you use. You are billed in real time based on the number of SMSs that are successfully sent. It is ideal when the usage is unpredictable or demands fluctuate sharply.
- Monthly billing: prepaid mode in which you pay in advance for the service based on the purchased specifications. It is a better option when the demand is stable, such as mature services.
 - SMS packages (pay-per-use billing upon SMS package runout): The excess SMSs are automatically charged in pay-per-use mode.
 - Resource packages (suspension upon resource package runout): When the resources in the package are used up, the service is automatically stopped.

◯ NOTE

In monthly billing mode, the system uses SMS packages (pay-per-use billing upon SMS package runout) by default. To change to resource packages (suspension upon resource package runout), contact the account manager or submit a service ticket. For details, see What Are the Differences Between Pay-per-Use Billing upon SMS Package Runout (Mode 1) and Suspension upon Resource Package Runout (Mode 2)?

Account Rules

- Message & SMS is a prepaid service. Top up your Huawei Cloud account to use it.
- An SMS package or a resource package is bound to one account and cannot be used by different accounts.

Pay-per-Use Billing

2.1 Overview

Scenarios

Pay-per-use billing is applicable when the usage is unpredictable or demands fluctuate sharply.

◯ NOTE

Scenarios that required pay-per-use billing:

- Sending Chinese mainland SMSs
- Sending international SMSs without SMS packages, sending international SMSs beyond the package quota, and sending International SMSs to countries and regions other than Indonesia, Thailand, India, and Philippines

SMS prices vary by target country or region. For details about the price, see Pricing Details.

Billing Rules

You are billed for sending SMSs by calling APIs or using Group SMS Assistant. An SMS is not charged if its returned **status** or status code is an error code from Huawei platform (error code in **SMS Status Error Codes** whose **Status Code Source** is **Huawei platform**).

If the number of characters in an SMS exceeds the length limit, the platform splits the SMS into multiple short messages. For details about how to calculate the number of SMSs, see **SMS Content Length Calculation**.

Billing Formulas

Fee = Used resources x Unit price

For details about the SMS price under pay-per-use billing mode, see **Pricing Details**.

Huawei Cloud changes the prices of SMSs sent to some countries (or regions) by Message & SMS. The new prices will take effect on November 1, 2024, 00:00:00 GMT+08:00. Subsequent purchases and renewals will be billed based on the new prices in the following table. SMS prices are updated in real time because cost changes result in price fluctuations. The latest prices prevail.

2.3 Impacts of Arrears

With pay-per-use billing, you can always use Message & SMS as long as your account has enough balance. If your account goes into arrears, the account enters a grace period and then a retention period. If your account enters the grace period, your SMS sending will be disabled. The added SMS signatures and templates will not be deleted.

Arrears Reminder

The system will bill you for pay-per-use resources after each billing cycle ends. If your account goes into arrears, we will notify you by email, SMS, or in-app message.

Handling Arrears

If your account is in arrears, your SMS sending will be disabled. You need to pay the fees of your used pay-per-use resources. To view the fees, go to the **Billing Center > Overview** page. Huawei Cloud will deduct the fees after you top up your account. For details, see **Topping Up an Account**.

3 SMS Packages (Pay-per-Use Billing upon SMS Package Runout)

3.1 Overview

Introduction

You can purchase a monthly SMS package to save more. The excess will be billed on a pay-per-use basis. For details, see Purchase Process.

When an SMS package expires, you can still use Message & SMS, and you will be billed for subsequent resources you use on a pay-per-use basis as long as you have sufficient balance in your account.

NOTICE

- SMS packages are only available for international SMSs.
- An SMS package is bound to one account and cannot be used by different accounts.
- You cannot unsubscribe from SMS packages, so plan the quota and validity period carefully before making your purchase.
- An SMS package takes effect immediately after your purchase. It becomes invalid upon expiration and cannot be extended. Unused quotas cannot be refunded.
- An SMS package cannot be used for the fees generated before the purchase.
- Currently, SMS packages are only available for sending SMSs to the following countries: Indonesia, Thailand, India, and Philippines. For SMS sending to other countries or regions, use the pay-per-use mode.
- If the SMS package quota is about to be used up, buy a new package.

Billing Rules

• After you purchase an SMS package, the quota of the package is used first when you send SMSs. The excess SMSs will be billed on a pay-per-use basis.

- If two SMS packages of the same type are purchased in sequence, the SMS package that takes effect first is used first. The second one will not be used until the quota of the first SMS package is used up.
- If the number of characters in an SMS exceeds the length limit, the platform splits the SMS into multiple short messages. For details about how to calculate the number of SMSs, see SMS Content Length Calculation.
- Verification code and notification SMSs are charged in the same way.
- You are billed for sending SMSs by calling APIs or using Group SMS Assistant.
- You are not billed for SMSs whose **status** parameter or status code is a Huawei platform error code.

Package Use Sequence

Use Sequence

If there are multiple SMS packages with the same attributes, they will be used in the order of their effective and expiration times.

SMS packages you purchase at the same time have the same effective time and expiration time.

Example

Scenario

A customer subscribes to two SMS packages for sending SMSs to Thailand.

- Package A: provides 10,000 SMSs, takes effect on May 1, and has one-month validity period (expires on June 1).
- Package B: provides 50,000 SMSs, takes effect on May 10, and has one-month validity period (expires on June 10).

Use Sequence	
May 1 to May 9	Only package A takes effect.
	Only package A is used. If the number of sent SMSs exceeds 10,000, pay-per-use billing is used.
May 10 to May 30	Both packages A and B take effect.
	Package A is used first. If the number of sent SMSs exceeds 10,000, package B is used. If the number of sent SMSs exceeds 60,000, pay-peruse billing is used.
June 1 to June 9	Package A has expired, and only package B takes effect.
	Only package B is used. If the number of sent SMSs exceeds 50,000, pay-per-use billing is used.

Both packages A and B have expired. Any subsequent usage is billed on a pay-per-use
basis.

3.3 Purchase Process


You can purchase SMS packages to implement the monthly billing for Message & SMS. You cannot unsubscribe from SMS packages, so plan the quota and validity period carefully before making your purchase.

Precautions


- Before purchasing an SMS package, see Overview.
- You are advised to enable the Message & SMS service, apply for an SMS template, and get it approved before purchasing an SMS package. Otherwise, your SMS services may fail to be approved or SMS packages cannot be used.

Procedure

 Log in to the Message & SMS console, choose Overview, and choose International SMS.



2. Click **Buy SMS Package**.



Parameter	Description
SMS Type	Regional SMS package, which can be used only for sending verification code and notification SMSs.
Specifications	Currently, SMS packages are only available for sending SMSs to the following countries: Indonesia, Thailand, India, and Philippines.
	Purchased SMS packages cannot be unsubscribed from or modified. Select proper specifications based on your service volume.

- 3. Check the information and click **Next** in the lower right corner.
- 4. Confirm the order and click **Submit**.
 - If the order information is incorrect, click **Previous** to modify it and then continue with your purchase.
- 5. Complete the payment as prompted.
- 6. Use Message & SMS.

The system automatically matches the package with SMSs based on attributes. For an SMS with the same attribute, the package is automatically used for the SMS sending fee. If the package quota is used up, the SMS will switch to pay-per-use billing.

Follow-Up Operations

You must set the traffic threshold in a timely manner by referring to **Settings** after purchasing an SMS package due to the following reasons:

- Adjusting the traffic threshold can reduce losses caused by SMS bombing.
- SMS package usage and pay-per-use consumption (actual number of SMSs sent) are limited by the default traffic threshold. After purchasing an SMS package, adjust the limit values in a timely manner to prevent services from being affected.
- There is a delay of no more than 2 hours for SMS package quota deduction (view the remaining quota by referring to SMS Package Details). After the SMS package quota is used up, the SMS will switch to pay-per-use billing. To prevent the billing mode change and enable automatic SMS suspension, set the limit value of the total number of SMSs sent per month to the value in SMS package specifications. For example, set the limit value to 50,000 if your SMS package is Thailand 50,000. By default, the maximum limit value of the total number of SMSs sent per month is 10,000. You can submit a service ticket to increase the upper limit.

3.4 SMS Package Details

You can view the usage details of the purchased SMS packages in Huawei Cloud Billing Center.

Procedure

- 1. Log in to Huawei Cloud Billing Center.
- 2. In the navigation pane, choose **Resource Packages**.
- 3. On the page displayed, click the name or ID of the target package to check its details.
 - Click Usage Statistics to view the deduction chart of the service.
 - Click Export Deduction Details to export the usage details.

Checking the Remaining Package Quota

Message & SMS provides two billing modes: pay-per-use and monthly.

If you have subscribed to monthly resource packages, do as follows to view the remaining quota of your package.

- Log in to Huawei Cloud Billing Center.
- 2. In the navigation pane, choose **Resource Packages**.
- 3. Click the **Resource Packages** tab and search for your packages by package name/ID or order number. You can then view the remaining quota or export the usage details.

4. Click the **Remaining Quotas** tab, specify a region and an enterprise project, and select **Message & SMS** to view the remaining quota of all your SMS packages.

3.5 Expiration and Overdue Payment

Handling Process

When your account is in arrears, you can continue using any remaining resources from valid packages. However, if there are no valid packages available, you cannot use Huawei Cloud Message & SMS.

View the outstanding amount of your account in the **Billing Center** and pay the outstanding amount by referring to **Making Repayments**.

Impact

- If your account is in arrears and enters the grace period, your SMS sending will be disabled. The added SMS signatures and templates will not be deleted.
- When your account balance is used up and your account enters the retention period due to using other Huawei Cloud services, your SMS sending will also be disabled.

Balance Alert

- If you are using a traffic package, you are advised to enable the usage alert function. If the remaining quota of the traffic package drops below a configured threshold, an SMS or email will be sent to you.
- To avoid unavailability of Message & SMS due to account arrears, top up your account when receiving a balance warning notification from the system. For details, see Topping Up an Account.

4 Resource Packages (Suspension upon Resource Package Runout)

4.1 Overview

Introduction

You can purchase a monthly resource package to save more. When the resource is used up, the system automatically stops SMS sending.

NOTICE

- Resource packages are only available for international SMSs.
- A resource package is bound to one account and cannot be used across accounts or regions.
- You cannot unsubscribe from resource packages, so plan the quota and validity period carefully before making your purchase.
- A resource package takes effect immediately after your purchase. It becomes invalid upon expiration and cannot be extended. Unused quotas cannot be refunded.
- Currently, resource packages are only available for sending SMSs to the following countries: Indonesia, Thailand, India, Philippines, Mexico, Brazil, Chile, Peru, and Dominican Republic.
- A resource package is suspended when it is used up. Buy a new resource package timely. Resource packages you purchase at the same time have the same effective time and expiration time.

Billing Rules

• After you purchase a resource package, the quota of the package is used when you send SMSs. When the quota is used up, the system automatically stops SMS sending. Buy a new resource package to continue using the service.

- If two resource packages of the same type are purchased in sequence, the resource package that takes effect first is used first. The second one will not be used until the quota of the first resource package is used up.
- Verification code and notification SMSs are charged in the same way.
- You are billed for sending SMSs by calling APIs or using Group SMS Assistant.
- You are not billed for SMSs whose **status** parameter or status code is a Huawei platform error code.

Package Use Sequence

Use Sequence

If there are multiple resource packages with the same attributes, they will be used in the order of their effective and expiration times.

Resource packages you purchase at the same time have the same effective time and expiration time.

Example

Scenario

A customer subscribes to two resource packages for sending SMSs to Thailand.

- Package A: provides 10,000 SMSs, takes effect on May 1, and has one-month validity period (expires on June 1).
- Package B: provides 50,000 SMSs, takes effect on May 10, and has one-month validity period (expires on June 10).

Use Sequence	
May 1 to May 9	Only package A takes effect. Only package A is used. If the number of sent SMSs exceeds 10,000, the system automatically stops SMS sending.
May 10 to May 30	Both packages A and B take effect. Package A is used first. If the number of sent SMSs exceeds 10,000, package B is used. If the number of sent SMSs exceeds 60,000, the system automatically stops SMS sending.
June 1 to June 9	Package A has expired, and only package B takes effect. Only package B is used. If the number of sent SMSs exceeds 50,000, the system automatically stops SMS sending.
After June 10	Both packages A and B have expired. The system automatically stops SMS sending.



Precautions


- Before purchasing a resource package, see Overview.
- Learn about template and variable specifications before purchasing a resource package. Otherwise, misoperations may cause your SMS services rejected or resource packages unusable.

Procedure

 Log in to the Message & SMS console, choose Overview, and choose International SMS.



2. Click Buy Resource Package.



Parameter	Description
Resource Package Type	Regional resource package, which can be used only for sending verification code and notification SMSs.
Specifications	 The resource package is used up. Currently, resource packages are only available for sending SMSs to the following countries: Indonesia, Thailand, India, Philippines, Mexico, Brazil, Chile, Peru, and Dominican Republic. Purchased resource packages cannot be unsubscribed from or modified. Select proper specifications based on your service volume.
Validity Period	The validity period is one month. Unused quotas cannot be refunded. Use up quotas within the validity period.
Quantity	You can purchase one resource package at a time. The number of purchases is not limited. If you want multiple resource packages, make multiple purchases.

- 3. Check the information and click **Next** in the lower right corner.
- 4. Confirm the order and click **Submit**.

If the order information is incorrect, click **Previous** to modify it and then continue with your purchase.

- 5. Complete the payment as prompted.
- 6. Use Message & SMS.

The system automatically matches the package with SMSs based on attributes. For an SMS with the same attribute, the package is automatically

used for the SMS sending fee. If the package quota is used up, the system stops SMS sending.

Follow-Up Operations

You must set the traffic threshold in a timely manner by referring to **Settings** after purchasing a resource package due to the following reasons:


- Adjusting the traffic threshold can reduce losses caused by SMS bombing.
- Resource package usage (actual number of SMSs sent) is limited by the default traffic threshold. After purchasing a resource package, adjust the limit values in a timely manner to prevent services from being affected.

4.4 Remaining Quota


You can view the usage details of the purchased resource packages on the Message & SMS console. For details about how to set the remaining resource package threshold, see **Resource Package Management**.
