# 1 Billing Overview

---

This topic introduces how SecMaster is billed along with details about billing modes, billing items, renewals, and accounts in arrears.

- **Billing modes**

SecMaster supports two billing modes, yearly/monthly and pay-per-use billing, to meet requirements in different scenarios. Yearly/Monthly is a prepaid mode. You need to pay first, and will be billed based on the required duration in your order. Ensure that your account balance is sufficient. Pay-per-use billing is a postpaid mode. In this mode, you pay for what you used. For more details, see [Overview](#).

- **Billing items**

The billing items of SecMaster consist of the service edition, quota, and value-added package. The value-added package includes large screen, security analysis, security orchestration, security data collection, and security data retention. For details about SecMaster billing items and calculation formulas, see [Billing Items](#).

Different billing calculation formulas are used based on billing modes. For details about billing examples, see [Billing Examples](#).

- **Renewal**

Once the yearly/monthly SecMaster expires, it cannot work. If you want to continue using SecMaster, you need to renew it within the specified period, or all configurations in workspaces will be deleted and data may be lost. You can enable auto-renewal for SecMaster or manually renew it before it expires. For more details about renewal, see [Overview](#).

- **Bills**

You can go to **Billing & Costs > Bills** and view bills and expenditures for your SecMaster resources. For details, see [Bills](#).

- **Overdue payment**

Your account goes into arrears when the balance cannot cover the bill you need to pay. If your account is in arrears, the service cannot work. You need to top up your account in a timely manner. For details, see [Arrears](#).

- **Billing termination**

If you no longer need SecMaster, you can unsubscribe from or delete it to stop the billing. For details, see [Billing Termination](#).

- **Cost management**

You can manage your costs from 4 dimensions: composition, allocation, analysis, and optimization. For details, see [Cost Management](#).

# 2 Billing Modes

## 2.1 Overview

SecMaster supports two billing modes, yearly/monthly and pay-per-use billing, to meet requirements in different scenarios.

- Yearly/Monthly is a prepaid billing mode. You pay in advance for a subscription term. The longer you use the service, the more discounts you got.
- Pay-per-use billing is a postpaid mode in which you pay for what you use. You are billed by second based on the actual usage. Your bill is settled by the hour. With the pay-per-use billing mode, you can easily adapt to resource requirement changes, reducing the risk of over-provisioning of resources or lacking capacity. In this mode, there are no upfront commitments required.

**Table 2-1** lists the differences between the billing modes.

<p><b>NOTE</b> Value-added packages cannot be purchased separately. To buy a value-added package, you should have purchased the standard or professional edition. Value-added packages are billed separately. There is no impact on the service edition and quota you have purchased.</p>		

## 2.2 Yearly/Monthly Billing

Yearly/Monthly billing is a prepaid billing mode in which you pay before using resources. It is suitable when your resource requirements are fixed because you can pay less by using longer. In the yearly/monthly billing mode, we offer discounts to you. This topic describes the billing rules of yearly/monthly SecMaster resources.

### Application Scenarios

In yearly/monthly billing mode, you need to pay for a required duration in advance. This mode is suitable for long-term and relatively fixed service requirements. The yearly/monthly billing mode is recommended for the following scenarios:

- Long-term workloads with stable resource requirements, such as official websites, online malls, and blogs.
- Long-term projects, such as scientific research projects and large-scale events
- Workloads with predictable traffic bursts, for example, e-commerce promotions or festivals.
- Workloads with high data security requirements

### Billing Items

The following billing items support yearly/monthly billing:

**Table 2-2** Billing items

Billing Item		Description
Edition		SecMaster edition, including basic, standard, and professional editions.
Quota		The quantity of the ECS quota.
Value-added package	Large screen	If you have purchased a yearly/monthly SecMaster edition, the large screen service you buy separately is also billed on a yearly/monthly basis.
	Log audit	If you have purchased a yearly/monthly SecMaster edition, the security data collection and retention services you buy separately are also billed on a yearly/monthly basis.
	Security analysis	If you have purchased a yearly/monthly SecMaster edition, the security analysis package you buy separately is also billed on a yearly/monthly basis.
	Security orchestration	If you have purchased a yearly/monthly SecMaster edition, the security orchestration service you buy separately is also billed on a yearly/monthly basis.

If you plan to purchase the professional edition SecMaster with one quota, as well as the large screen, security data collection (5 GB/day), security data retention (100 GB/day), security analysis (1 GB/day), security orchestration (10,000 operations/day), and select the yearly/monthly billing mode (the required duration is one month), at the bottom of the SecMaster purchase page, you can view the fee details.

The price includes:

- Professional edition: the fees for the professional edition and the quota you specify.
- Large screen - security situation metrics: the fee for SecMaster large screen.
- Security orchestration: the fee for the playbooks execution quota you specify.
- Security analysis package: the fee for security analysis data volume you specify.
- Security data collection: the fee for daily data collection volume you specify.
- Security data retention: the fee for daily log retention volume you specify.

## Billing Period

The billing period of yearly/monthly SecMaster is determined by the required duration (UTC+8:00). The billing period starts from the time you activate or renew your subscription (precise to seconds), and ends at 23:59:59 on the expiration date.

For example, if you purchase the SecMaster professional edition with one quota for one month at 15:50:04 on June 30, 2024 (no value-added package is purchased), the billing period is from 15:50:04 on June 30, 2024 to 23:59:59 on July 30, 2024.

## Billing Examples

Assume that you purchased a yearly/monthly SecMaster professional edition (Quota: 1) at 15:50:04 on June 30, 2024, as well as the value-added package, including large screen, security data collection (5 GB/day), security data retention (100 GB), security analysis (1 GB/day), and security orchestration (10,000 operations/day). Billing resources include the professional edition, quota, and value-added package. Your subscription is one month and you manually renew the subscription for another month before the subscription expires. The billing details are as follows:

- The first billing period is from 15:50:04 on June 30, 2024 to 23:59:59 on July 30, 2024.
- The second billing period is from 23:59:59 on July 30, 2024 to 23:59:59 on Aug. 30, 2024.

You must prepay for each billing period. [Table 2-3](#) shows the billing formula.

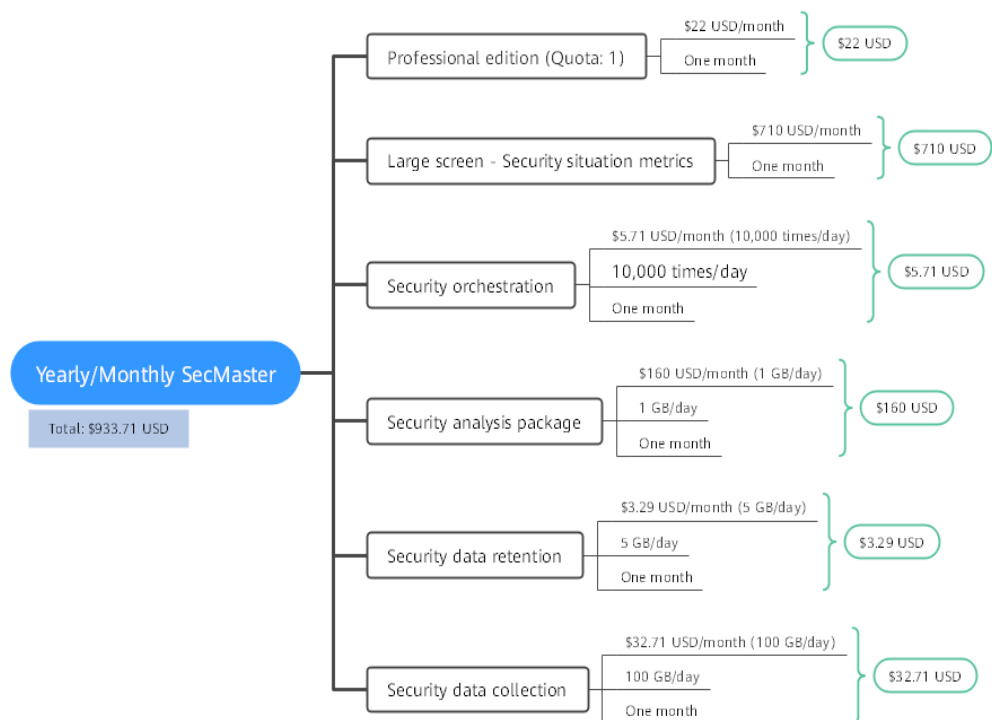

Service edition + Quota	(Service edition + Quota) x Required duration
Security data collection	Security data collection package price x Required duration
Security data retention	Security data retention package price x Required duration

Resource Type	Billing Formula
Large screen	Large screen - Security situation metric price x Required duration
Security analysis	Price of security analysis data volume per day x Required duration
Security orchestration	Number of execution times of workflow nodes (including the start and end nodes, but excluding judgment nodes) per day during playbook execution x Required duration

## Impact on Billing After Specification Changes

If you change the current specifications of your yearly/monthly SecMaster to meet your service changes, the following pricing rules are used:

Upgrading the edition or specifications: You need to pay the price difference.

### NOTE

Currently, SecMaster does not support changing the edition in use to a one with lower specifications. If you want to use SecMaster of an earlier edition, unsubscribe from the one you are using first and subscribe to the one you want.

Assume that you purchased the standard yearly/monthly SecMaster (ECS quota: 1) edition for one month on June 8, 2024 without any discount and you changed SecMaster to the professional edition on June 18, 2024. The price of the old configuration is \$2.2 USD/month, and that of the new configuration is \$22 USD/month. The formula is as follows:

**Specification upgrade fee = New specification price × Remaining period - Old specification price × Remaining period**

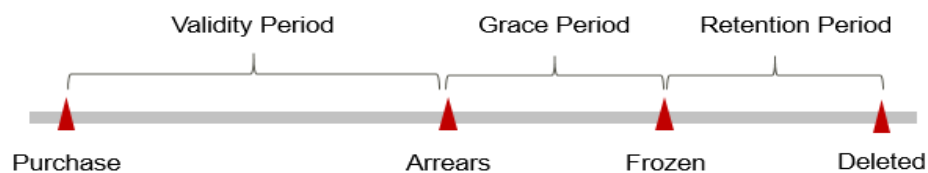
The remaining period in the formula is the remaining days of each calendar month divided by the maximum days of corresponding calendar month. In this example, the remaining period = 12 (Remaining days in June)/30 (Maximum number of days in June) + 8 (Remaining days in July)/31 (Maximum number of days in July) = 0.6581. Price difference = 22 × 0.6581 - 2.2 × 0.6581 = \$13.03 USD

## Impacts of Expiration

[Figure 2-3](#) describes the status of yearly/monthly SecMaster resources in each phase. After purchasing a resource, it remains operational throughout the billing cycle. This can be referred to as the validity period. If the resource is not renewed after expiration, it enters the grace period and then the retention period.

**Figure 2-3** Yearly/Monthly SecMaster lifecycle



### Expiration reminder

From the 7th day before a yearly/monthly SecMaster edition expires, the system will send an expiration reminder to the creator of the account by email, SMS, and internal message.

### Impact of expiration

If your yearly/monthly SecMaster resources expire and are not renewed, the resources enter the grace periods. During the grace period, you can use the SecMaster service.

If you do not renew your yearly/monthly SecMaster before the grace period ends, it goes into the retention period and its status turns to **Frozen**. You cannot perform any operations on such instances in the retention period.

If the yearly/monthly SecMaster resources are still not renewed after the grace period ends, the SecMaster resources will be released, and data cannot be restored.

 NOTE

## 2.3 Pay-per-Use Billing

Pay-per-use billing is a postpaid mode in which you pay for what you use. This billing mode requires no upfront or long-term commitments. Only the professional edition and value-added package in SecMaster can be billed on a pay-per-use basis. This section describes the billing rules of pay-per-use SecMaster resources.

### Application Scenarios

Pay-per-use billing is suitable for applications or services that cannot be interrupted but have unpredictable or sudden traffic surges, such as flash sale activities on e-commerce platforms, temporary testing, and scientific computing.

### Billing Items

The following billing items support pay-per-use billing.

**Table 2-4** Billing items

Billing Item		Description
Service edition		SecMaster edition. Only the <b>professional edition</b> supports the pay-per-use billing mode.
Quota		The quantity of the ECS quota.
Value-added package	Large screen	If you have purchased a pay-per-use SecMaster edition, the large screen service in value-added package you buy separately is also billed on a pay-per-use basis.
	Log audit	If you have purchased a pay-per-use SecMaster edition, the security data collection and retention services you buy separately are also billed on a pay-per-use basis.
	Security analysis	If you have purchased a pay-per-use SecMaster edition, the security analysis package you buy separately is also billed on a pay-per-use basis.
	Security orchestration (SOC)	If you have purchased a pay-per-use SecMaster edition, the SOC service you buy separately is also billed on a pay-per-use basis.

If you purchase the professional edition SecMaster with one quota, as well as large screen, security data collection, security data retention, security analysis, and security orchestration, and select the pay-per-use billing mode, at the bottom of the SecMaster purchase page, you can view the fee details.

The price includes:

- Professional edition: the fees for the professional edition and the quota you specify.
- Large screen - security situation metrics: the fee for SecMaster large screen.
- Security analysis package: the fee for security analysis data volume you use.
- Security data collection: the fee for the security data collected for you.
- Security data retention: the fee for the total volume of logs stored for you.
- Security orchestration: the fee for playbook execution times.

## Billing Period

Pay-per-use SecMaster resources are billed by second. Bills are settled on each integer hour (UTC+ 08:00). After the settlement is complete, a new billing period starts. The billing starts from the time when SecMaster is purchased, and ends at the time when pay-per-use billing is disabled.

For example, if you purchase a pay-per-use SecMaster edition (Quota: 1) at 8:45:30, and delete it at 8:55:00, the billing period is from 8:00:00 to 9:00:00. Fees are generated for the duration from 8:45:30 to 8:55:30, and the billing duration is 600 seconds.

## Billing Examples

Assume that you purchased the pay-per-use professional edition SecMaster (Quota: 1) and the value-added package that includes large screen, security data collection, security data retention, security analysis, and security orchestration at 09:59:30 on June 08, 2024, and deleted them at 10:45:46 on June 08, 2024. During the billing period, you used SecMaster to complete 1 GB/per day of security analysis, to execute 500 times of security orchestration, to collect 5 GB/day of logs, and to store 100 GB logs. The billing periods of **service edition + quota** and **large screen** are as follows:

- The first billing period is from 9:00:00 to 10:00:00. Fees are generated from 9:59:30 to 10:00:00. The billing duration is 30 seconds within the period.
- The second billing period is from 10:00:00 to 11:00:00. Fees are generated from 10:00:00 to 10:45:46. The billing duration is 2,746 seconds within the period.

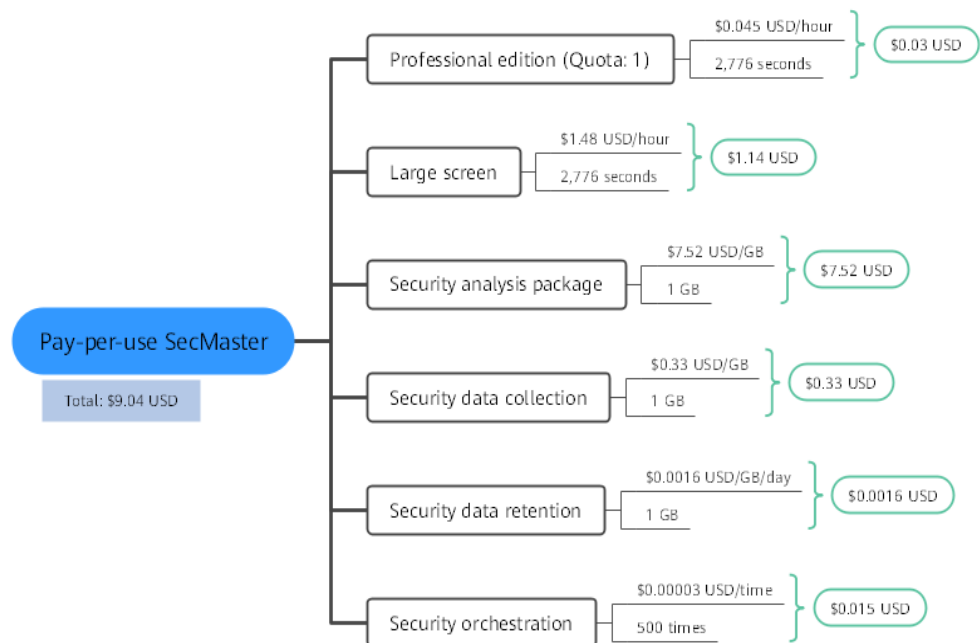
You need to pay for each billing period, and SecMaster resources are billed individually. The billing formula is shown in [Table 2-3](#). The price of a resource listed in the product pricing details is per hour, so divide it by 3,600 to obtain the price for each second.

**Table 2-5** Billing formulas

Resource Type	Billing Formula
Service edition + Quota	Service edition + Quota unit price x Billing duration
Large screen	Large screen price x Billing duration
Security data collection	You are billed for the actual volume of collected logs.
Security data retention	You will be billed for the actual volume of stored logs.
Security analysis	You will be billed for the actual security analysis data volume.
Security orchestration	You will be billed for how many times workflow nodes (including the start and end nodes, but excluding judgement nodes) are executed during playbook execution.

## Impact on Billing After Specification Changes

If you change the quota after a pay-per-use purchase, a new order will be generated based on the new price. The old order automatically becomes invalid.

If you change the quota within an hour after a purchase, multiple billing records will be generated. Different records record the billing for different specifications.

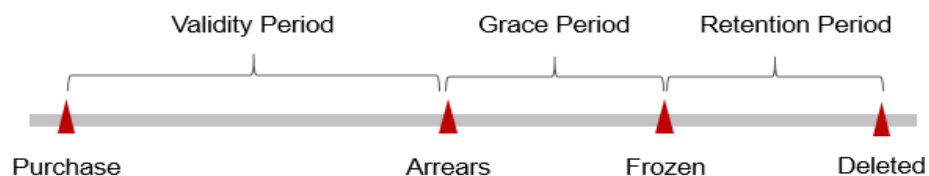
For example, if you purchase the SecMaster professional edition with quota set to one at 9:00:00 and increase the quota to two at 9:30:00, two pieces of billing records will be generated for the duration between 9:00:00 and 10:00:00.

- The first billing record is for the professional edition and the quota of one for the duration from 09:00:00 to 09:30:00.
- The second billing record is for the professional edition and the quota of two for the duration from 09:30:00 to 10:00:00.

## Impact of Arrears

[Figure 2-6](#) describes the status of pay-per-use SecMaster resources in different periods. After you purchase SecMaster resources, the period during which the resources run properly within the billing cycle is the validity period. If your account is in arrears due to failed payments for the pay-per-use SecMaster resources, the resources enter the grace period and then retention period.

### Arrears notifications

The system deducts fees from your account balance for pay-per-use resources at the end of each billing cycle. If your account is in arrears, we will notify you by email, SMS, or internal message.

### Arrears impacts

Your account may fall into arrears if it cannot cover the pay-per-use fees for resources. However, your pay-per-use resources will not be stopped immediately. There will be a grace period. You need to pay the pay-per-use resource fees incurred during the grace period. To view the fees, go to the **Billing Center > Overview** page. The system will charge the fees once you top up your account.

If you do not pay the arrears within the grace period, the resource enters the retention period and its status turns to **Frozen**. You cannot perform any operations on pay-per-use resources in the retention period.

If you do not pay off the arrears within the retention period, your SecMaster resources will be released, and data will be lost.

## Billing Description

The billing items of SecMaster consist of the service edition, quota, and value-added package. For details, see [Table 3-1](#).

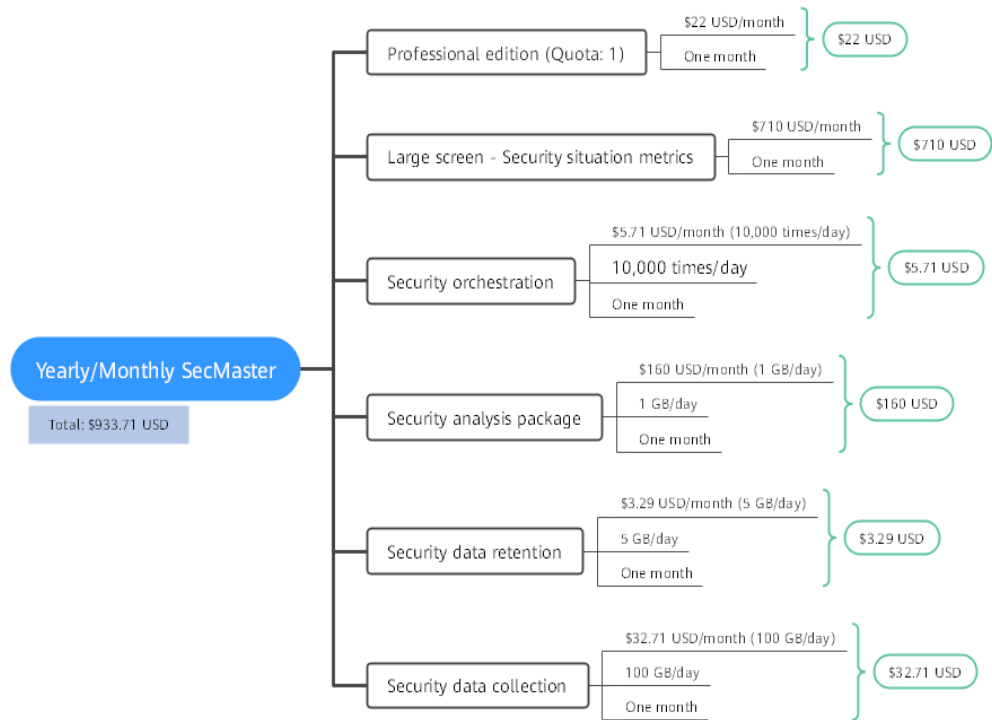

- The first billing period is from 15:50:04 on June 30, 2024 to 23:59:59 on July 30, 2024.
- The second billing period is from 23:59:59 on July 30, 2024 to 23:59:59 on Aug. 30, 2024.

# 4 Billing Examples

---

## Scenarios

On June 8, 2024, a customer purchased the SecMaster standard edition with one quota for one month and purchased the value-added package (large screen, security data collection, security data retention, security analysis, and security orchestration). The specifications are as follows:

- Service edition + Quota: Standard edition + 1 quota
- Value-added package:
  - Large screen - Security situation metrics
  - Security data collection: 5 GB/day
  - Security data retention: 100 GB
  - Security analysis: 1 GB/day
  - Intelligent analysis: 1 GB/day
  - Security orchestration: 10,000 times/day

After a period of time, the customer found that the current SecMaster specifications could not meet their service requirements and upgraded SecMaster on June 18, 2024. The service edition was upgraded to the professional edition. The new specification configuration is as follows:

- Service edition + Quota: Professional edition + 1 quota
- Value-added package:
  - Large screen - Security situation metrics
  - Security data collection: 5 GB/day
  - Security data retention: 100 GB
  - Security analysis: 1 GB/day
  - Intelligent analysis: 1 GB/day
  - Security orchestration: 10,000 times/day

So, how much is the fee from June to July? Let's start from scratch.

## Billing Analysis

- Service edition + Quota:

In this case, you need to pay the difference in price. The old price of the standard edition is \$2.2 USD/quota/month, and the old price of professional edition is \$22 USD/quota/month. The formula is as follows:

**Specification upgrade fee = New specification price × Remaining period - Old specification price × Remaining period**

The remaining period in the formula is the remaining days of each calendar month divided by the maximum days of corresponding calendar month. In this example, the remaining period =  $12$  (Remaining days in June)/ $30$  (Maximum number of days in June) +  $8$  (Remaining days in July)/ $31$  (Maximum number of days in July) =  $0.6581$ . Price difference =  $22 \times 0.6581 - 2.2 \times 0.6581 = \$13.03$  USD

From June to July, the total fee for the service edition and quota is \$ 15.23 USD ( $2.2 + 13.03$ ).

- Value-added package:

The billing of the value-added package is irrelevant to the service edition. It is related only to the configured quota and required duration. So, the billing of the value-added package remains unchanged after the edition is upgraded.

From June to July, the total fee for the value-added package is \$911.71 USD ( $710 + 160 + 5.71 + 3.29 + 32.71$ ).

From June to July, the total fee for using SecMaster is \$926.94 USD ( $15.23 + 911.71$ ).



# 5 Changing the Billing Mode

---

Currently, the billing mode of SecMaster cannot be directly changed.

To change the billing mode, unsubscribe from or cancel the current subscriptions first. Then you can select the billing mode you need while making a new purchase.

# 6 Renewing Your Subscription

## 6.1 Overview

### When to Renew Subscriptions

After your yearly/monthly SecMaster expires, it cannot be used anymore. If you want to continue using SecMaster, you need to renew it within the specified period.

Only yearly/monthly SecMaster subscriptions can be renewed. If you use pay-per-use SecMaster, just ensure that your account has a valid payment method configured or a top-up account with a sufficient balance.

If you renew your SecMaster before it expires, resources will be retained and you can continue using it. For details, see [Impacts of Expiration](#).

### How to Renew Subscriptions

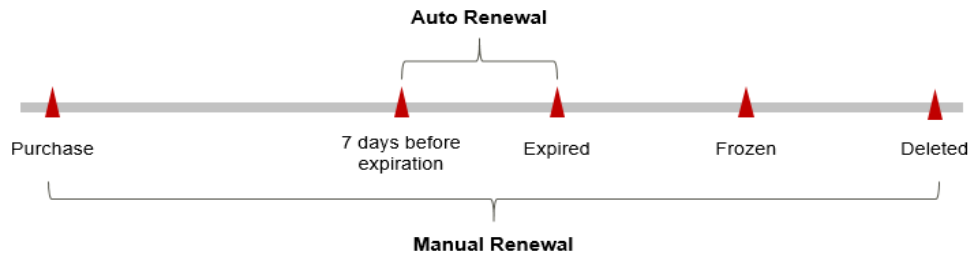
[Table 6-1](#) describes renewal methods for yearly/monthly SecMaster subscriptions.

**Table 6-1** Renewal-related functions

Function	Description
<a href="#">Manually Renewing SecMaster</a>	For yearly/monthly SecMaster, you can renew it on the SecMaster console at any time as long as it has not been deleted automatically.
<a href="#">Auto-renewing SecMaster</a>	After auto-renewal is enabled, SecMaster automatically renews your subscription before the subscription expires. This prevents resources from being automatically deleted if you forget to manually renew the subscription.

In different phases of the lifecycle of a yearly/monthly SecMaster instance, you can choose a renewal mode best fits your needs. For details, see [Figure 6-1](#).

Figure 6-1 SecMaster Lifecycle



- SecMaster works properly and its functions are available from the time it is purchased to the time it expires.
- If the resource fails to be renewed before expiration, SecMaster enters the grace period first. If the resource still fails to be renewed after the grace period expires, the resource is frozen.
- If it still failed to be renewed when the grace period expires, the instance enters the retention period. If you do not renew it within the retention period, the resource will be deleted automatically.


Auto-renewal can be enabled before your SecMaster instance expires. The system will automatically renew the instance at 3:00 a.m. on the seventh day before it expires. If the auto-renewal fails, the system will try again at 3:00 a.m. every day until your SecMaster resource expires or the renewal is successful. Renewing resources 7 days before expiration is a default value. You can change it if needed.

## 6.2 Manually Renewing SecMaster

For yearly/monthly SecMaster, you can renew it on the SecMaster console at any time as long as it has not deleted automatically.

### Renewing a Subscription on the Console

**Step 1** Log in to the management console.

**Step 2** Click  in the upper left corner of the page and choose **Security & Compliance** > **SecMaster**.

**Step 3** In the navigation pane on the left, choose **Purchased Resources**. Locate the target region in the displayed list on the page, click **Renew**. The **Renewals** page of the **Billing Center** is displayed.

**Step 4** Locate the row containing the desired SecMaster instance and click **Renew**.

**Step 5** On the renewal page, select the renewal duration, for example, 1 year.

**Step 6** (Optional) Set **Renewal Date**. By default, the renewal time is set to 23:59:59 GMT +08:00 on the first day of each month.

**Step 7** Click **Pay**.

## Renewing a Subscription in the Billing Center

- Step 1** Log in to the management console.
- Step 2** In the upper right corner of the page, choose **Billing & Costs > Renewal**. The **Renewals** page is displayed.
- Step 3** On the **Manual Renewals** tab page, locate the SecMaster instance you want to renew, click **Renew** in the **Operation** column.
- Step 4** On the renewal page, select the renewal duration, for example, 1 year.
- Step 5** (Optional) Set **Renewal Date**. By default, the renewal time is set to 23:59:59 GMT +08:00 on the first day of each month.
- Step 6** Click **Pay**.

## 6.3 Auto-renewing SecMaster

Auto-renewal makes renewal easier and prevents SecMaster instances from being automatically deleted if you forget to manually renew them. The auto-renewal rules are as follows:

- The first auto-renewal date and billing cycle are calculated based on the expiration date of your SecMaster instance.
- The SecMaster auto-renewal duration is of your choice; for example, if you set the subscription duration to three months, SecMaster will be automatically renewed for another three months before expiration.
- Auto-renewal can be enabled before your SecMaster instance expires. The system will automatically renew the instance at 3:00 a.m. on the seventh day before it expires. If the auto-renewal fails, the system will try again at 3:00 a.m. every day until your SecMaster resource expires or the renewal is successful.
- You can still perform a manual renewal even when auto-renewal is enabled. After a manual renewal is complete, auto-renewal is still in effect, and the system will start deducting renewal fees from your account 7 days before the new subscription expires.
- By default, the system automatically deducts fees from your account 7 days before your instance expires. You can change the renewal date to another day if needed, for example, 6 days or 5 days before the instance expires.

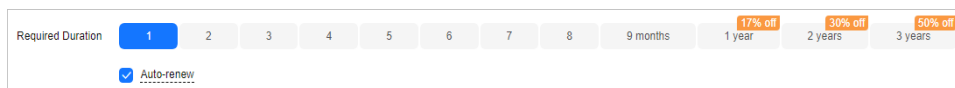
### Prerequisites

Ensure that the yearly/monthly SecMaster has not expired.

## Enabling Auto-Renewal on the Renewals Page

- Step 1** Log in to the management console.
- Step 2** In the upper right corner of the page, choose **Billing & Costs > Renewal**. The **Renewals** page is displayed.
- Step 3** Customize search criteria.
  - On the **Auto Renewals** page, you can view the resources for which auto-renewal has been enabled.
  - You can enable auto-renewal for resources on the **Manual Renewals**, **Pay-per-Use After Expiration**, and **Renewals Canceled** pages.
- Step 4** Locate the target SecMaster instance and click **Enable Auto-Renew** in the **Operation** column.
- Step 5** Select the renewal duration and the number of auto-renewal times.
- Step 6** Click **OK**.

# 7 Bills

You can view bills in the **Billing Center** to learn about the usage and billing details of the resource in a certain period.


## Bill Generation

After you pay for a yearly/monthly resource, a bill is reported to the billing system in real time for settlement.

The usage of pay-per-use resources is reported to the billing system at a fixed interval. Pay-per-use products can be settled by the hour, day, or month based on the usage type. Pay-per-use SecMaster resources are settled by the hour.

You are not charged immediately after a billing record is generated. For example, if SecMaster (which is billed on an hourly basis) is disabled at 08:30, your expenditures for the hour from 08:00 to 09:00 will not likely be billed until about 10:00. On the **Billing Center > Billing > Transactions and Detailed Bills > Transaction Bills** page, **Expenditure Time** indicates the time when a pay-per-use product is used.

## Viewing Bills of a Specific Resource

- Step 1** Log in to the management console.
- Step 2** In the upper right corner of the page, choose **Billing & Costs > Bills**.
- Step 3** In the navigation tree on the left, choose **Billing > Expenditure Details**.
- Step 4** In the **Settings** area, click , select **Service Type**, and then select **SecMaster(SecMaster)** in the **Service Type** column. The system displays the bills of the service.

By default, expenditure details are displayed by usage and the statistical period is a billing cycle. You can also set other statistical dimensions and periods.

## Checking the Consistency of the Actual Usage and Billed Usage

Assume that a customer purchased the professional edition pay-per-use SecMaster (ECS quota: 1) at 10:09:06 on April 8, 2024 and deleted it at 12:09:06 on April 8, 2024.

- SecMaster transaction bill  
In pay-per-use billing mode, SecMaster is billed by the second and the bill is settled hourly. You can check the information about each billing period in the transaction bill. For details, see [Table 7-1](#).

<b>List Price</b>	List price = Usage x Unit price In this example, the usage of SecMaster in the first billing period is 3,054 seconds. If the unit price is \$0.05/ECS/hour, the list price is $(3,054 \div 3,600) \times 0.05 = \$0.04241667$ . You can query the actual unit price in <a href="#">SecMaster Pricing Details</a> . Similarly, you can calculate the SecMaster list price for other billing periods.
<b>Discount</b>	Discounts offered for cloud services, for example, commercial discounts, partner authorized discounts, and promotional discounts. Discounts are based on the list prices.
<b>Truncated Amount</b>	Huawei Cloud bills a resource with the price accurate to the eighth decimal place. However, the amount due is truncated to the second decimal place, while the third and later decimal places are referred to as the truncated amount. Take the first billing period as an example. The truncated amount is \$0.00241667 USD.
<b>Amount Due</b>	Amount due = List price - Discount amount - Truncated amount Take the first period as an example. If the discount amount is 0, the amount due is \$0.04 USD (0.04241667 - 0 - 0.00241667).

- SecMaster bill details

Bill details are displayed by multiple dimensions. By default, the bill details of a resource are displayed by usage and by billing cycle. You can check bill details by referring to [Table 7-2](#).

# 8 Arrears

---

Your account goes into arrears when the balance cannot cover the bill you need to pay. If your account is in arrears, the service cannot work. You need to top up your account in a timely manner.

## Arrears Reasons

Your account balance cannot cover the fees for the pay-per-use standard edition, professional edition, or value-added packages you have purchased.

## About Arrears

- Yearly/Monthly billing

Yearly/monthly SecMaster resources are paid when you make the purchase. So you can still use the yearly/monthly SecMaster resources you have purchased even if your account goes into arrears. However, you cannot perform other operations that may incur fees, such as purchasing new edition SecMaster, upgrading SecMaster specifications, or renewing subscriptions.

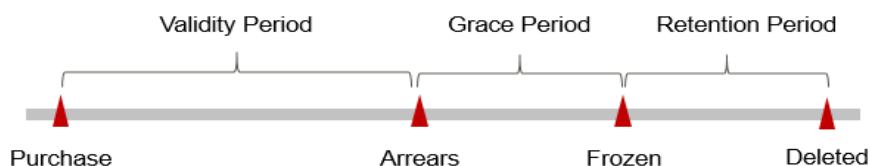
- Pay-per-use billing

Your account may fall into arrears after pay-per-use fees for SecMaster are deducted from the account balance. However, your pay-per-use resources will not be stopped immediately. There will be a grace period. You need to pay the pay-per-use resource fees incurred during the grace period. To view the fees, go to the **Billing Center > Overview** page. The system will charge the fees once you top up your account.

If you do not pay the arrears within the grace period, the resource enters the retention period and its status turns to **Frozen**. You cannot perform any operations on pay-per-use resources in the retention period.

If you do not pay off the arrears within the retention period, your SecMaster resources will be released, and data will be lost.

## Avoiding and Handling Arrears

You need to top up your account once it is in arrears.

If you no longer need SecMaster, unsubscribe from it to avoid unexpected fees.

Configure the **Balance Alert** function on the **Billing Center > Overview** page. When the total amount of the available quota, general cash coupons, and cash coupons is lower than the threshold, the system automatically notifies you by SMS or email.

If your account is in arrears, top up your account in time.

# 9 Billing Termination

To prevent resource waste and unnecessary fees, you can stop billing for unused resources.

- In yearly/monthly billing, if you are using the standard or professional edition, asset quotas and value-added packages (large screen, security analysis, and security orchestration) need to be unsubscribed or canceled separately.

After all asset quotas (professional edition or standard edition) are unsubscribed from and the current edition is the basic edition, you can unsubscribe from the value-added package features.

The value-added package functions depend on the service edition. If you unsubscribe from or cancel the professional or standard edition but do not unsubscribe from or cancel the value-added package, the corresponding functions cannot work. So you need also cancel the value-added package features.

- In the **pay-per-use** professional edition, when you unsubscribe from or cancel the asset quota of the professional edition, functions in the value-added package are also unsubscribed or canceled.

## NOTE

- If you have enabled data collection, you need to manually release the ECSs used for data collection. For details, see [How Do I Unsubscribe from ECSs?](#)
- If you have enabled data collection, you need to manually release the VPCEP nodes used to connect and manage the collection nodes. For details, see [Deleting a VPC Endpoint](#).


## Yearly/Monthly Resources


For yearly/monthly-billed resources, such as a yearly/monthly SecMaster, you pay the bills when you purchase them. Billing automatically stops when the subscription expires.

- You can unsubscribe from a yearly/monthly resource before the subscription expires. Fees for unused resource will be refunded to you based on refund conditions, including the five-day unconditional unsubscription conditions and whether cash coupons or discount coupons are used. For details, see [Unsubscriptions](#).

- If you have enabled the auto-renewal function, disable it before the auto-renewal deduction date (seven days before the expiration date by default) to avoid unexpected fees.

**Step 1** Log in to the management console.

**Step 2** Click  in the upper left corner of the management console and select a region or project.

**Step 3** Click  in the upper left corner of the page and choose **Security & Compliance > SecMaster**.

**Step 4** On the displayed page, click **Standard** or **Professional** in the upper right corner. A window for you to manage SecMaster assets will be displayed.

**Step 5** In the row of the ECS quota or value-added package billed on a yearly/monthly basis, click **Unsubscribe**.

**Step 6** Locate the row that contains the target instance, and click **Unsubscribe** in the **Operation** column.

**Step 7** Confirm the information about the resource to be unsubscribed, select the unsubscription reason, and select **I understand a handling fee will be charged for this unsubscription**.

**Step 8** Click **Confirm**.

Go to the edition management window and verify that the subscription to the ECS quota that is billed yearly/monthly is canceled.

----End


## Pay-per-Use Resources


For resources billed on a pay-per-use basis, such as the professional edition SecMaster, you need to unsubscribe from them if you no longer need them. The billing stops once you complete the unsubscription.

### NOTE

The system usually deducts fees of the last settlement period within one hour after the products are used. As a result, after a pay-per-use resource is deleted, the bill information may still exist. For example, if you delete a pay-per-use SecMaster resource at 08:30, the fees generated from 08:00 to 09:00 are usually settled at about 10:00.

**Step 1** Log in to the management console.

**Step 2** Click  in the upper left corner of the management console and select a region or project.

**Step 3** Click  in the upper left corner of the page and choose **Security & Compliance > SecMaster**.

**Step 4** Click **Professional** in the upper right corner. The edition management window is displayed.

**Step 5** In the row of the SecMaster edition purchased in pay-per-use billing mode, click **Cancel** to release the purchased SecMaster resources.

Go to the edition management window and verify that the subscription to resources billed on a pay-per-use basis is canceled.

# 10 Cost Management

---

As more and more enterprises move workloads to the cloud, cloud costs are drawing more attention. How to manage costs and reduce service loads when using SecMaster is also our concerns. The following describes how to manage costs from four dimensions: cost composition, allocation, analysis, and optimization, to help maximize return on your investment.

## Cost Composition

When using SecMaster, you will use some resources, which depend on billing items of SecMaster you are using. For details, see [Billing Items](#).

## Cost Allocation

A good cost accountability system is the basis of cloud financial management. It ensures that departments, business teams, and owners are accountable for their respective cloud costs. Allocate costs to different teams or projects so that organizations have a clear picture of their respective costs.

We provide multiple tools for you to optimize cost allocation in [Cost Center](#).

- **Allocate costs by linked account.**

The enterprise master account can categorize the costs of its member accounts by linked account to manage the accounting of those member accounts. For details, see [Viewing Costs by Linked Account](#).

- **Allocate costs by cost category.**

You can use **Cost Categories** in [Cost Center](#) to split shared costs. Shared costs include the costs for the resources (compute, network, storage, or resource packages) shared across multiple departments or the costs that cannot be directly split by cost tag or enterprise project configured for the resources. These costs are not directly attributable to a singular owner, and hence cannot be categorized into a singular cost category. In this case, you can define cost splitting rules to fairly allocate these costs among teams or business units. For details, see [Viewing Cost by Cost Category](#).

## Cost Analysis

To accurately control and optimize your costs, you need a clear understanding of what parts of your enterprise incurred different costs. [Cost Center](#) visualizes

original costs and amortized costs in various dimensions and through filters so that you can analyze service usage costs, trends, and factors from a variety of perspectives and scopes.

You can also use **Cost Anomaly Detection** in **Cost Center** to detect unexpected expenses in a timely manner. In this way, costs can be monitored, analyzed, and traced.

## Cost Optimization

- **Cost control**

You can create different types of budgets on the **Budgets** page of Cost Center to track your costs against the budgeted amount you specified and send alerts to the recipients you configured if the thresholds you defined are reached. You can also create budget reports and we will periodically generate and send to the recipients you configured on a schedule you set.

For example, an enterprise needs to create a monthly cost budget for SecMaster. The monthly budget is \$2,000 USD. The system should send an alarm when the forecast amount is greater than 80% of the budget amount. Then, the created budget is as follows:

- **Resource optimization**

**Cost Center** can help monitor the historical expenditures and resource usage of SecMaster, identify idle resources, and provide optimization suggestions so that you can reduce costs as much as possible.

- **Billing mode selection**

Different types of services have different requirements on resource usage periods and therefore require different billing modes to achieve the optimal outcome.

- For long-term stable mature services, yearly/monthly billing mode is recommended.
- For short-term, unpredictable services that experience traffic bursts and cannot be interrupted, pay-per-use billing is recommended.



# 11 Billing FAQs

---

## 11.1 How Is SecMaster Billed?

SecMaster supports yearly/monthly and pay-per-use billing.

- Yearly/Monthly billing  
The longer the subscription duration, the lower the price. The yearly/monthly billing is paid based on the subscription period.
- Pay-per-use billing  
You are billed for usage duration by hour. This billing mode allows you to enable or disable the SecMaster service at any time.

## 11.2 Can I Use SecMaster for Free?

Yes.

SecMaster provides basic, standard, and professional editions.

- You can use the basic edition for free for a long time.
- The standard and professional editions are billed for what you use. The **Value-added package** is billed separately.

## 11.3 How Do I Change or Disable Auto Renewal for SecMaster?

This topic walks you through on how to cancel or modify auto-renewal after you have configured it for SecMaster.

## Canceling Automatic Renewal of SecMaster

You can disable auto-renewal for SecMaster anytime you want. Note that you need to manually renew SecMaster before it expires when auto-renewal is disabled.

## 11.4 Will SecMaster Be Billed After It Expires?

After SecMaster expires, you will not be charged anymore.



If you do not renew your subscription after it expires, a retention period is provided based on the customer level and subscription mode. During the retention period, you cannot access or use SecMaster resources, but the data stored in SecMaster resources is retained. If it still fails to be renewed within the retention period, the standard or professional edition you are using will become the basic edition.

## 11.5 How Do I Renew SecMaster When It Is About to Expire?

Renewal only extends the validity period of the original edition you have bought. During the renewal, the specifications of **ECS Quota** and **Value-added package** cannot be changed.

Only yearly/monthly subscriptions can be renewed.

## Manually Renewing SecMaster

- Step 1** Log in to the management console.
- Step 2** Click  in the upper left corner and select the region and project.
- Step 3** Click  in the upper left corner of the page and choose **Security & Compliance > SecMaster**.
- Step 4** In the navigation pane on the left, choose **Purchased Resources**. Locate the target region in the displayed list, click **Renew**. The **Renewals** page under the billing center is displayed.
- Step 5** Locate the row containing the desired SecMaster instance and click **Renew**.
- Step 6** Specify **Renewal Duration**, for example, **1 year**.
- Step 7** (Optional) Set **Renewal Date**. By default, the renewal time is set to 23:59:59 GMT +08:00 on the first day of each month.

**Step 8** Complete the payment.

**Step 9** Return to the **Renewals** page and check the SecMaster subscription status.

## Enabling Auto-Renewal

**Auto-renewal** applies to the services billed on a yearly/monthly basis. When your account balance is abundant and auto-renewal is enabled, the ECS quota, value-added package, and security orchestration features will be automatically renewed.

**Step 1** Log in to the management console.

**Step 2** On the top part of the page, choose **Billing > Renewal**.

**Step 3** On the **Manual Renewals** tab, select the SecMaster professional edition instance and click **Enable Auto-Renew**.

**Step 4** Specify the auto-renewal period and set the number of preset auto-renewals.

**Step 5** Click **OK**.

**Step 6** Go back to the previous page, select the **Auto Renewals** tab, and verify the auto-renewal status of your SecMaster.

Your SecMaster subscriptions will be automatically renewed based on your configurations.

## 11.6 Where Can I Unsubscribe from SecMaster?

If you no longer need SecMaster, unsubscribe from it or cancel it in just a few clicks.

- Yearly/Monthly billing mode: a prepaid mode. You can unsubscribe from a purchased cloud service and apply for a full refund unconditionally within five days of the purchase. Each account can request five-day unconditional full refund for 10 times in a year. Handling fees are required if you unsubscribe from a service over five days after it is purchased.
- Pay-per-use billing mode: Pay for what you use by the hour. This mode allows you to enable or disable resources at any time. One-click resource cancellation is also supported.

### Limitations and constraints


- In the standard and professional editions charged **Yearly/Monthly**, the asset quota and value-added packages need to be unsubscribed or canceled separately.


After all asset quotas (professional edition or standard edition) are unsubscribed from and the current edition is the basic edition, you can unsubscribe from the value-added package features.

- In the **pay-per-use** professional edition, when you unsubscribe from or cancel the asset quota of the professional edition, functions in the value-added package are also unsubscribed or canceled.
- The value-added packages cannot be used independently.  
If you have subscribed to the value-added packages on your standard or professional edition, after you unsubscribe from the standard or professional edition, no data will be available for the value-added packages. So you still need to cancel subscriptions to the value-added package.
- After unsubscribing from SecMaster, you need to manually release the following resources:
  - If you have enabled data collection, you need to manually release the ECSs used for data collection. For details, see [How Do I Unsubscribe from ECSs?](#)
  - If you have enabled data collection, you need to manually release the VPCEP nodes used to connect and manage the collection nodes. For details, see [Deleting a VPC Endpoint](#).

**Step 2** Click  in the upper left corner and select the region and project.

**Step 3** Click  in the upper left corner of the page and choose **Security & Compliance > SecMaster**.

**Step 4** Click **Standard** or **Professional** in the upper right corner. A window for you to manage SecMaster assets will be displayed.

**Step 5** In the row of the ECS quota or value-added package billed on a yearly/monthly basis, click **Unsubscribe**.

**Step 6** Locate the row that contains the target instance, and click **Unsubscribe** in the **Operation** column.

**Step 7** Confirm the information about the resource to be unsubscribed, select the unsubscription reason, and select **I understand a handling fee will be charged for this unsubscription**.

**Step 8** Click **Confirm**.


Go to the edition management window and verify that the subscription to the ECS quota billed yearly/monthly is canceled.

## Canceling Pay-per-Use SecMaster Resources

**Step 2** Click  in the upper left corner and select the region and project.

**Step 3** Click  in the upper left corner of the page and choose **Security & Compliance > SecMaster**.

**Step 4** Click **Professional** in the upper right corner. The edition management window is displayed.

**Step 5** In the row of the SecMaster edition purchased in pay-per-use billing mode, click **Cancel** to release the purchased SecMaster resources.


Go to the edition management window and verify that the subscription to resources billed on a pay-per-use basis is canceled.

**Step 5** Unsubscribe from a value-added package.

- For pay-per-use value-added packages:  
Click **Cancel** to release the pay-per-use asset quota. Go to the edition management window and verify that the subscription to resources billed on a pay-per-use basis is canceled.
- For yearly/monthly billed value-added packages:
  - a. Click **Unsubscribe** to go to the **Unsubscriptions** page.
  - b. Locate the row that contains the target instance, and click **Unsubscribe** in the **Operation** column.
  - c. Confirm the information about the resource to be unsubscribed, select the unsubscription reason, and select **I understand a handling fee will be charged for this unsubscription**.
  - d. Click **Confirm**.  
Go to the edition management window and verify that the subscription to the ECS quota billed yearly/monthly is canceled.

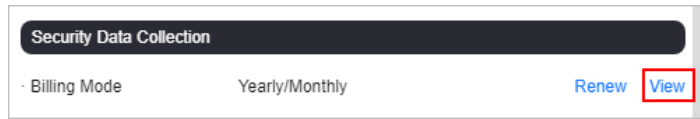

## 11.7 Where Can I View the Remaining Quotas of Security Data Collection and Security Data Packages?

1. In the upper right corner of the **Security Overview** page, hover over **Standard** or **Professional**. The edition management window is displayed.
